SETTING THE TIME

- Pull the CROWN out completely.
- Slowly rotate the CROWN CLOCKWISE or COUNTERCLOCKWISE to the desired time.
- Push the CROWN in completely to restart the watch.

SETTING THE DATE

- Pull the CROWN out halfway
- Slowly rotate the CROWN COUNTER CLOCKWISE the desired date.
- Push the CROWN in completely to restart the watch.

CARE AND FEEDING

Avoid exposing your watch to water, steam, or other forms of moisture if it is non-water-resistant. If the crystal/lens becomes damaged, have it replaced at once to avoid damage to the module. When your battery is depleted, have it replaced promptly.

BATTERY REPLACEMENT

When your battery is depleted, have it replaced promptly. The particular type of battery provides the power to operate your GuardDog[™] watch.

Because of possible loss, we recommend insuring your watch, return receipt requested, when using the mails. If you do not obtain a receipt within a reasonable time, start a tracer through the originating post office. Never include a special watchband or any other article of personal value in your shipment. Please note that we may substitute a watch of equal value and similar appearance for yours on both in-warranty and out-of-warranty repairs.

WARNING!

We know a great many of you are very handy when it comes to working with tools and equipment and you may be tempted to attempt repairs or routine maintenance to the GuardDogTM watch. Despite your considerable skill, we think it's just not a good idea. Here's why:

Your GuardDog™ Watch has a press fit back. While is is possible for you to remove the case back yourself you might incur trouble getting it back into place properly.

Failure to re-seat the caseback may compromise the protective seals which protect the quartz movement from moisture. Damage to the case or the watch during this process would void your warranty.

Further, during production, a special tool is used to press fit the case into place properly. Jewelers and specialty watch repair retailers have the proper tools and offer these services for slightly more than the cost of the battery. We strongly encourage you to leave all repairs and maintenance to our authorized service center or a facility with the proper tools.

ONE YEAR WARRANTY

This GuardDog™ quartz, analog watch is warranted to the owner for a period of one year from the date of purchase by GuardDog Watch and Clock, LLC – and not from the dealer from whom the watch was purchased. This means that if the watch materials aren't right or the watch wasn't assembled correctly, we'll take care of it. But, this doesn't mean you can abuse your watch or that we'll cover normal wear and tear. Like all watches, our warranty doesn't cover batteries, crystal, watch case, strap, bracelet, loss, or theft. Opening the case back, not screwing down the crown if you have a screw crown, or pushing the buttons underwater will void the warranty.

We recommend you use extreme care when working with power and hand held tools including wearing proper eye and hearing protection. It may be prudent to remove any objects which might get snagged or caught when operating machinery, including your GuardDogTM watch.

This warranty does not cover:

- 1.) Defects related to servicing not performed by a GuardDog Watch and Clock, LLC authorized service center
- 2.) GuardDog Watch and Clock, LLC will not provide warranty service if your watch shows evidence it has been tampered with, misused, abused, or altered in any way
- a. Moisture damage sufficient enough to affect the proper function of the watch
- b. Damage to the case
- c. Visible cracking of the crystal/lens
- 3.) GuardDog Watch and Clock, LLC reserves the right to charge you for a replacement battery if the battery in your watch is depleted. No additional charge will be made unless the one year warranty period has expired or servicing is necessary for reasons beyond our control, in which case a moderate charge will be made.
- 4.) GuardDog Watch and Clock, LLC is not liable for incidental, special or consequential damages. Some states do not allow the exclusion or limitation of incidental, special or consequential damages, so the above exclusion or limitation may not apply to you.

Your rights under implied warranties and state law: This limited warranty is in lieu of all other expressed warranties, obligations or liabilities. GuardDog Watch and Clock, LLC limits the duration of any warranty implied by state law, including but not limited to the implied warranties of merchantability and fitness for a particular purpose, to one year from the date of original purchase. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
